1 The types information that we collect, process, hold and share include:

- personal information (such as name, employee or teacher number, national insurance number)
- contact information (such as telephone number, address, email)
- special categories of data including characteristics such as gender, age, ethnic group
- contract information (such as start dates, hours, post, salary & payroll information)
- work absence information (such as number of absences and reasons)
- qualifications and training records
- medical information, where relevant

2 Why we collect and use this information

We use school workforce data to:

- to provide a comprehensive picture of the workforce and how it is deployed
- inform the development of recruitment and retention policies
- enable individuals to be paid
- to meet our duty of care to protect and safeguard those within the school community

The lawful basis on which we process this information

We process this information under Article 6 of the GDPR 2018, sections 1a), c), d) or e), plus Article 9, sections 2a), b), c), d), e), f), g) or h).

As both uses and purposes can vary, the specific section(s) that form the basis at any one time may vary within those listed.

3 Collecting this information

Whilst the majority of information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with data protection legislation, we will inform you whether you are required to provide certain school workforce information to us or if you have a choice in this.

4 Storing this information

For full details of how long we hold school workforce data, please ask to see our 'Records Management Policy.'

5 Who we share this information with

We routinely share this information with:

- The Local Authority
- The Department for Education (DfE)
- Children's Endeavour Trust C.E.T. (the Multi Academy Trust we belong to)

6 Why we share school workforce information

We do not share information about workforce members with anyone without consent unless the law and our policies allow us to do so.

7 Local authority & Department for Education (DfE)

We are required to share information about our workforce members with our local authority (LA) and the Department for Education under section 5 of the Education (Supply of Information about the School Workforce) (England) Regulations 2007 and amendments.

This data sharing underpins workforce policy monitoring, evaluation, and links to school funding / expenditure and the assessment educational attainment.

8 Data collection requirements

The DfE collects and processes personal data relating to those employed by schools (including Multi Academy Trusts) and local authorities that work in state funded schools (including all maintained schools, all academies and free schools and all special schools including Pupil Referral Units and Alternative Provision). All state funded schools are required to make a census submission because it is a statutory return under sections 113 and 114 of the Education Act 2005

The department may share information about school employees with third parties who promote the education or well-being of children or the effective deployment of school staff in England by:

- conducting research or analysis
- producing statistics
- providing information, advice or guidance

The department has robust processes in place to ensure that the confidentiality of personal data is maintained and there are stringent controls in place regarding access to it and its use. Decisions on whether DfE releases personal data to third parties are subject to a strict approval process and based on a detailed assessment of:

- who is requesting the data
- the purpose for which it is required
- the level and sensitivity of data requested; and
- the arrangements in place to securely store and handle the data

To be granted access to school workforce information, organisations must comply with its strict terms and conditions covering the confidentiality and handling of the data, security arrangements and retention and use of the data.

9 Requesting access to your personal data

Under data protection legislation, you have the right to request access to information about you that we hold. To make a request for your personal information, contact the school office.

You also have the right to:

 object to processing of personal data that is likely to cause, or is causing, damage or distress

- prevent processing for the purpose of direct marketing
- object to decisions being taken by automated means
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed; and
- claim compensation for damages caused by a breach of the Data Protection regulations
